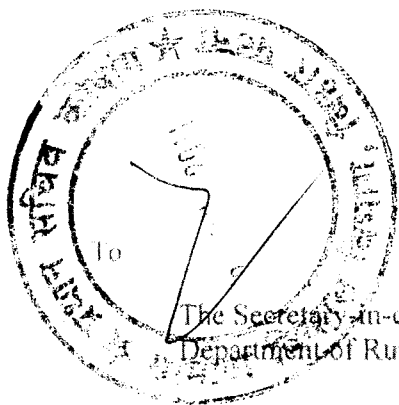

Sub :- Optimal utilization of Data Entry Operators (DEOs) provided by Central Public Sector Undertaking (CPSU) for Socio-Economic and Caste Census 2011 (SECC 2011)

Sir,

As you are aware, the Socio-Economic and Caste Census is being conducted throughout India and has formally been launched in Tripura on 29.06.11. A consortium of CPSUs which include BEL, ITI and ECIL has been appointed to assist State Governments in data collection by providing Data Entry Operators (DEOs). Tablet PCs required for the work will be supplied by BEL.

State wise details of assigned CPSUs and the name and designations of coordinators is as given in Annexure.

It may please be noted that CPSUs are providing assistance to the State Governments and the State Governments have the prime responsibility to conduct the SECC 2011. For this purpose all DEOs and technical staff placed at the charge centres will be under the operational control of Charge officer and those at district and State level will be under the operational control of District Collectors and State Nodal Officers.

It has been reported in some places that services of DEOs are not being used optimally due to the unwillingness of enumerators and/or charge officers. In some cases, DEOs sat idle with the machines (Tablet PCs) for the whole day because the enumerators could not go for enumeration work. This leads to wastage of resources.
