On behalf of Ministry of Rural Development (MoRD), Govt. of India CAPART has been given the responsibility of organizing the **Shishir SARAS Fair from 15<sup>th</sup> to 28<sup>th</sup> February, 2015 at Dilli Haat Pitampura, Delhi**. Participation in SARAS Fair would present an excellent opportunity for rural craftsmen to demonstrate their skills and to sell their products. In this connection, the following are the points for your immediate attention and necessary action:

1. A total number of stalls (**as per list enclosed**) will be made available free of charge for your selected participants to display and sell their products (two participants per stall). CAPART will also provide the dormitory type accommodation (free of charge) to the participants in the premises of Dilli Haat, Pitampura itself. SHGs and beneficiaries of the SGSY/NRLM Scheme are qualified to participate.
2. You are requested to send your nominations to Marketing Division, CAPART in the enclosed format. The District Rural Development Agencies (DRDAs) may please be instructed to forward nominations through the State Government.
3. Kindly instruct the concerned official to request SHGs (Self help Groups) participating in the SARAS Fair not to use plastic bags during the Fair, as the use of plastic bags is prohibited in Delhi. SHGs may use paper, gunny, cloth bag, etc. instead.
4. The selected SHG members should be advised to strictly avoid bringing any prohibited items for display and sale e.g.; animal skins, hairs, conch shell, etc., which may attract penal action under the relevant laws.

In order to help us to make necessary arrangements, you are requested to confirm the participation by an early date and send your nominations latest by **5<sup>th</sup> February, 2015** positively with the details of the selected SHGs, the names of the participants, and their product lists etc.

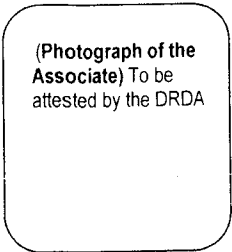
