

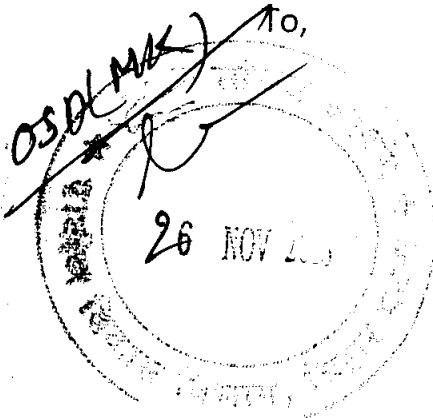

The items made in china or any other foreign country will not be permitted for sale in craft fair/mela. The identification of participants should be dully verified at the state level by the respective state Nodal Officer. A format for certificate and particulars of the nominated artisans/SHGs is given at **Annexure B**.


Each state shall be allocated 2 to 5 stalls for display and sale of the produce of their artisans/SHGs. The accommodation for the artisans and the accompanying state official, if any, would be provided during the event. Traveling expenses will be borne by Artisans himself or State Govt. concerned. Request for additional stalls for your state may please be communicated well in advance to enable us to make necessary arrangements. It is requested that the information relating to the participation may be sent to us within 1st December, 2015.

The participant artisan/ SHG may be advised to report at the office of Kurukshetra Development Board at Brahm Sarovar, Kurukshetra on 10th December 2015.
