**Minutes of the meeting Ombudsman Selection Committee of MGNREGA**

A meeting of the Ombudsman Selection Committee of MGNREGA was held under the chairmanship of Sri Phool Singh, Development Commissioner, Government of Bihar on 25.04.2013 at 4:00 PM. The following were also present in the meeting:-

1. Shri Amrit Lal Meena – Secretary, Rural Development Department, Bihar
2. Dr. K.K Tripathy- Director, MGNREGA, Ministry of Rural Development, New Delhi

2. The committee was apprised of the procedure followed for screening of candidates for selection of Ombudsman for remaining 27 districts of the state. Out of 226 online applications received, 37 were found eligible as per the instruction issued under Section 27 (1) of MGNREGA 2005 for establishment of the office of Ombudsman for redressal of grievances. Detailed applications of such candidates along with their CVs were placed before the committee.

3. Committee examined each and every eligible application. After careful consideration, following decisions were taken:

- a) 15 candidates (Annexure 1) were found suitable for provisional selection.
- b) With respect to 10 candidates (Annexure 2), the committee decided to seek clearance from District Administration. The District Administration would verify their qualification and experience in public administration and social service and give a detailed report for consideration of the committee.
- c) With respect to 4 candidates (Annexure 3), the committee decided to ascertain candidate's willingness to render full-time service as Ombudsman and also to seek proof of Social Services rendered by them, earlier.
- d) The panel of 15 provisionally selected candidates would be published on the departmental website ([www.rdd.bih.nic.in](http://www.rdd.bih.nic.in)) inviting comments from the public within 30 days of such publication. Simultaneously, report from concerned

administration department would also be obtained with respect to Retired Government Servants.

- e) The District Administration will also be requested to ascertain the political affiliations/ antecedents of all the candidates.
- f) The final list of candidates for appointment as Ombudsman would be prepared after examining comments received from the public regarding their candidature and would be appointed with the approval of the Chairman of this Ombudsman Selection Committee.


4. The meeting ended with a vote of thanks to the Chair.
