
## CORRIGINDUM

With reference to PR NO. 11383 by which Bihar Rural Development Society (BRDS) invited "RFP for Providing 15,000 to 20,000 POST PAID SIM Cards with DATA & CUG (Closed User Group) connections for BRDS". A pre-bid meeting on the above assignment was held on 09-01-2017 at BRDS office, Patna.

The prospective bidders submitted various suggestions during the said pre-bid meeting and the same have been considered by the Society from the point of view of healthy competition and accordingly some of the conditions are being modified. **All other conditions and Scope of work remain same as per the BID document.**
