

## Corrigendum

Based on the queries raised in Pre-bid meeting held on 20.09.2016 and subsequent discussions, the following changes in RFP issued vide Tender No.: RDD/05/2016/Aadhaar-01 dated 09-Sept-2016 are made:-

1. **Clause 2.6:** Tender Fee of **Rs. 10000/-** (Rupees Ten Thousand Only) to be paid through Demand Draft (DD) in favor of "**BRDS (UID-ENROLLMENT)**" payable at **Patna**. There will be only one tender fee of Rs 10000 for all Schedules a bidder is applying for. If a bidder is applying for more than one schedule, he should enclose original DD in the first schedule (he is applying for) and photo copy of the same in other schedules. Tender fee shall be non-refundable.
2. **Clause 2.21 b:** Performance Bank Guarantee will be from a **Schedule Commercial Bank** only promising payment of the guaranteed sum to the RDD, on demand within three working days without any demur whatsoever and without seeking any reasons whatsoever. The demand for payment by the RDD shall be treated as conclusive proof for payment. A model Bank Guarantee format is enclosed. (Annexure-E).
3. **Clause 3:** Any eligible bidder can apply for all the schedules but a bidder will be awarded maximum two (2) schedules only. The price bids for schedules will be opened and evaluated sequentially as given in this tender from schedule-1 to schedule-5. If any bidder is found L1 in two schedules, their price bids in subsequent schedules will not be opened. An eligible bidder technically qualified for allotment in only one schedule, can also apply for more than one schedules. However, if they are found L1 in a schedule, their price bid will not be opened in subsequent schedules.
4. **Clause 3:** For the Permanent Enrollment Center, Head /In-charge of local authority will be the custodian of all equipment of the PEC. In sweep/ camp mode enrolment, head/ in-charge of camp will be custodian of all equipment.
5. **Clause 3.01:** In sweep/camp mode enrollment, RDD will provide transportation support. Infrastructure and power will be provided by the local authority/ district authority for operation of the enrollment at the camp (sweep mode).
6. **Clause 4.01:** The bidder shall have an average turnover of Rs. 10 (Ten) Crore for the three consecutive financial years from Financial Year 2012-13 to Financial Year 2015-16 i.e. sum of turnover for the three consecutive years divided by three shall be minimum Rs. 10 (Ten) Crore for each schedule. Copies of audited financial statements or balance sheet certified by their appointed statutory auditor must be provided.
7. **Clause 4.07:** The authorization for signing the Bid document shall be indicated by a written power of attorney (in a legally valid stamp paper of minimum Rs. 1000/-(One Thousand) denomination) duly notarized from the competent authority accompanying the bid.



- 8. Clause 4.09:** The bidder shall submit an under taking on a legally valid stamp paper of minimum Rs.1000 (One Thousand) denomination as per Annexure-C.
- 9. Clause 6.03:** Provisional Payment of 80% of invoice amount will be released within seven (7) working days and remaining 20% after verification within 21 working days from the date of submission of monthly bills and reports. The following documents / records / Packets shall be submitted with the monthly bill: BME data packets' upload report, any other relevant documents as per requirement and Self-declaration stating that payment to the supervisory level operators and other manpower are disbursed through their bank account. The payment to the supervisory level operators and other manpower shall be made through their Bank accounts only. RDD reserves the right to audit the documents at any point of time.
- 10. Clause 7.03:** All orders for the schedules will be at the respective L1 rates. If there is a tie for L1 rate in a schedule, decision will be taken on the basis of lottery in front of the bidder.
- 11. Tender Calendar:** Last date of submission of tender will be 14<sup>th</sup> October 2016 till 3.00 pm and opening of Eligibility / Technical Bid will be held on 14<sup>th</sup> October 2016 at 3.30 pm.
