All other condition and Scope of Work remain same as per RFP .Following table brings out the dates for main events of the bidding process for this RFP. The Bidder should note that the Purchaser reserves the right to change these dates without assigning any reason at any stage of the bidding process.

2. REVISED PRE- QUALIFICATION CRITERIA OF BIDDERS

- A. Number of members in a consortium shall be restricted to maximum two companies registered under Indian Companies Act 1956 and at least one consortium partner must be an ISO 9001:2008 Certified Company. One of the members of the consortium should act as the lead bidder and be responsible to the Purchaser for discharging project responsibilities. However, both the consortium members will be jointly and severally responsible for the execution of the project. The bid should contain details of all the members of the consortium including their legal status and specify their roles and responsibilities in the project. The members of the consortium shall enter into an Agreement for the purpose of submitting the proposal and the same shall be submitted with the proposal, failing which bid will be summarily rejected.
- B. Projects executed for bidder's own or bidder's group of companies or bidder's consortium companies shall not be considered.
- C. The Bidder (Both Bidder in case of Consortium) must submit self attested copies of Company PAN Card, Incorporation certificate under Company Act 1956, MOA and AOA.
- D. The Bidder (Lead Bidder in case of Consortium) must submit self attested copies of Service Tax, VAT, PAN Card, PF and ESI certificates also along with the technical bid.
- E. The Bidder (Any Bidder in case of a Consortium) must have comprehensive experience in development and deployment of Mobile Application software and must be in the business of IT Services for at last 5 Years as per Company act 1956. Either in Government Sector or Govt PSUs.
- F. The Bidder (Lead Bidder in case of a Consortium) company/agency must be minimum average annual Turnover of Rs. 2.0 Crores (As on 31st March 2014) in the last 3 financial years from IT business only, as certified by the CA of the company. CA certificate/audited balance sheet should be submitted with Bid.
- G. The Bidder(Lead Bidder in case of a Consortium), should be profitable in during the last two financial years and Net worth of Company(Both Bidder in case of a Consortium)should be positive. CA certificate/audited balance sheet should be submitted with Bid.
- H. The bidder(Any Bidder in case of a Consortium) should have Developed, Implemented and maintained at least three (3) Mobile Based Application software (**Based for Android/IOS/Windows Phone) for Government Departments/PSUs**. Two of the implemented Mobile Apps should have used by minimum 100 employees of Government Sector or government PSUs.
- I. The Bidder (Any Bidder in case of a Consortium) should have experience of implementation of at least two(2) ICT/e-Governance projects for Government/PSUs (Involving software implementation, Integration, Post Implementation Support etc.) with a project value each of Rs. 2.00 Cr or above.

- J. The bidder (Any Bidder in case of consortium) must have prior experience of working on at least One(1) Mobile Application (Android, Windows, IOS) project for any State anywhere in India and **Replication done in multi districts of States of same application.**
- K. Bidder's (Any Bidder in case of a Consortium) Mobile Application (**Android, Windows ,and IOS**) Based project software should fulfill criteria's listed in 'Annexure II of RFP.
- L. The bidder (Any Bidder in case of consortium) must have prior Experience to handle minimum 50 Manpower in multi-location Indian Government/PSUs/State Govt. setup and Project duration must be at-least three years and Project value not less than 3Cr. Bidder must submit work order and agreement copy of project.
- M. The bidder (Both Bidder in case of a Consortium) should not have been blacklisted by any State / Central Government in India for corrupt, fraudulent or any other unethical business practices or for any other reason. **Bidder should submit the affidavit along with technical document.**
- N. Bidder's Company should be submit CA/ROC certificate regarding takeover/merger with other company/Firm/LLP (**if applicable**), in such case old company/firm/LLP credentials also be considered as Work Experience , Company Experience, Turnover criteria of bidder while in all such case company should be registered under Company act 1956 presently and old company/firm/LLP business should be from IT/Hardware/Software/Mobile Apps sector only.
- O. **The bidder must be able to submit the proof of concept as per customer requirement.**

Note : Project Executed in Indian/State Government , Indian/State Government PSUs, State Government will be considered. Private, Global or overseas orders not considered.

3. Other Revised terms and Conditions

3.1. Mobile Application Hosting

Mobile Application hosted in bidder data-centre or Cloud Infrastructure with following minimum requirements

- a. Data Center (DC) for hosting of the applications must be based India.
- b. DC Should have multiple data centres in different seismic zones of India so that proper provision of DC & DR can be made if required.
- c. DC should be Tier III or better.
- d. DC should have been in India in business for more than five years. Should be capable of providing hosting, collocations and various flavours of cloud services such as private, public and hybrid cloud services.
- e. DC should be ISO 20000-1, ISO 27001 certified. Copies of certifications for above must be produced.
- f. If system performance and reliability necessitates so, storage or backup may utilize data centres and cloud platforms outside India, after obtaining necessary clearance in writing from department.

3.2. Revised Payment Schedule:

Payment terms as per annexure-II of commercial sheet of this corrigendum, the payment schedule will be revised as follows:-

A: Service Charge of SaaS Application for three year

The selected service provider shall be paid on monthly basis at the end of each Month based on the Monthly invoices raised by the Service Provider, at the rates specified in the Contract and the basis of total users.

B. Training Charges (One Time)

90% on successful training.

10% against Performance Bank Guarantee valid for project period

C. Post Implementation support

The selected service provider shall be paid on monthly basis at the end of each Month based on the Monthly invoices raised by the Service Provider, at the rates specified in the Contract and the basis of total users.

D. Installation, Implementation Charges in Mobiles (One Time)

90% on successful Installations.

10% against Performance Bank Guarantee valid for project period

E. Manpower Support Services

The selected service provider shall be paid on Monthly basis at the end of each Month based on the Monthly invoices raised by the Service Provider, at the rates specified in the Contract.

3.3. Force Majeure

- a. Neither Party to MSA or to the SLA shall be liable to the other for any loss or damage which may be suffered by the other due directly to the extent and for the duration of any cause beyond the reasonable control of the Party ("Force Majeure") events such as, but not limited to, acts of God not confined to the premises of the Party claiming the Force Majeure, flood, drought, lightning or fire, earthquakes, strike, lock-outs beyond its control, labour disturbance not caused at the instance of the Party claiming Force Majeure, acts of government or other competent authority, war, terrorist activities, military operations, riots, epidemics, civil commotions etc. No failure, delay or other default of any contractor or sub-contractor to either Party shall entitle such Party to claim Force Majeure under this Article.
- b. The Party seeking to rely on Force Majeure shall promptly, within 2 days, notify the other Party of the occurrence of a Force Majeure event as a condition precedent to the availability of this defense with particulars detailed in writing to the other Party and shall demonstrate that it has taken and is taking all reasonable measures to mitigate the events of Force Majeure.
- c. In the event the Force Majeure substantially prevents, hinders or delays the Bidder's performance of Services necessary for project's implementation or the operation of Project's critical business functions for a period in excess of 5 days, the BRDS may declare that an emergency exists. However, when the situation arising out of Force Majeure comes to an end in the assessment of BRDS, the following conditions shall apply:
 - i. Prior to commencement of operations: If the event of Force Majeure had occurred prior to commencement of operations, upon its coming to an end the Bidder shall resume normal activities under the Agreement immediately. The BRDS, if it considers it necessary, may grant an extension of time to the Bidder for resuming normal activities under MSA. If the Bidder does not resume normal activities immediately or within the extended period, if any, granted by the BRDS, the BRDS will have the option to invoke the Performance Guarantee, and obtain substitute performance from an alternate supplier at the cost of Bidder and/or terminate MSA.
 - ii. Post commencement of operations: If Force Majeure had occurred post commencement of operations, upon its coming to an end, the Bidder shall resume normal services under MSA immediately. The BRDS, if he considers it necessary, may grant an extension of time to the Bidder for resuming normal services under MSA. However, the BRDS, or its nominee will deduct for each day of the extension period a percentage proportionate to the number of days and the volume(s) (measured in terms of ratio to the overall volume as recorded in the previous month) expected in the affected area(s) from the next payable amount as per Terms of Payment Schedule. If normal services are not resumed immediately or within the extended time, the BRDS will have the option to invoke the Performance Guarantee and/or terminate the Agreement.
- d. All payments pursuant to termination due to Force Majeure event shall be in accordance with the Terms of Payment Schedule. Notwithstanding the terms of this Article, the failure on the part of the Bidder under the MSA or terms under the SLA to implement any disaster contingency planning and back-up and other data safeguards against natural disaster, fire, sabotage or other similar occurrence shall not be an event of Force Majeure.

3.4. Data protection and use

- a. In the course of providing the Services the Bidder may be compiling, processing and storing proprietary Project Data relating to the users.
- b. The Bidder and each user are responsible for complying with its respective obligations under the applicable data protection laws and regulations governing the Project Data.
- c. As a processor of Project Data, the Bidder will process Project Data in accordance with the terms of MSA.
- d. The Bidder shall not transfer any Project Data to any person or organization unless otherwise authorized by the BRDS in this regard.

3.5. Service Level Agreement (SLA) Points

3.5.1. The service levels to be established for the Services offered by the Bidder to the BRDS. The Bidder shall monitor and maintain the stated service levels to provide quality service to the State.

3.5.2. Definitions:

- a. "**Scheduled Maintenance Time**" shall mean the time that the System is not in service due to a scheduled activity as defined in this SLA. The scheduled maintenance time would not be during 10X6 timeframe. Further, scheduled maintenance time is planned downtime with the prior permission of the BRDS.
- b. "**Scheduled Operation Time**" means the scheduled operating hours of the System for the month. All scheduled maintenance time on the system would be deducted from the total operation time for the month to give the scheduled operation time. The total operation time for the HRMS applications will be 24X7X365 subject to SDC availability.
- c. "**System or Application Downtime**" means accumulated time during which the System is totally inoperable within the Scheduled Operation Time but outside the scheduled maintenance time and measured from the time the State and/or its employees log a call with the Bidder team of the failure or the failure is known to the Bidder from the availability measurement tools to the time when the System is returned to proper operation.
- d. "**Availability**" means the time for which the services and facilities are available for conducting operations on the state system including application and associated infrastructure. Availability is defined as: $\{(Scheduled\ Operation\ Time - System\ Downtime) / (Scheduled\ Operation\ Time)\} * 100\%$.
- e. "**Helpdesk Support**" shall mean the 10x6 basis support centre which shall handle Fault reporting, Trouble Ticketing and related enquiries during this contract.
- f. "**Incident**" refers to any event / abnormalities in the functioning of the Data Centre Equipment / Services that may lead to disruption in normal operations of the Data Centre, System or Application services.

3.5.3. Interpretations.

- a. The business hours are 9:30AM to 6:00PM on all working days (Mon-Sat) excluding Public Holidays or any other Holidays observed by the State. The Bidder however recognizes the fact that the BRDS offices will require to work beyond the business hours on need basis.
- b. "Non-Business Hours" shall mean hours excluding "Business Hours".

- c. The SLA parameters shall be monitored on a monthly basis as per the individual SLA parameter requirements. However, if the performance of the system/services is degraded significantly at any given point in time during the contract and if the immediate measures are not implemented and issues are not rectified to the complete satisfaction of the state or an agency designated by them, then the state will have the right to take appropriate disciplinary actions including termination of the contract.

3.5.4. SLA Definition & Measurement

As this project is a System Integration project, the implementation portion of the Agreement between BRDS and the selected Bidder will be in the form of a Service Level Agreement, as provided in this Schedule of the Master Services Agreement (MSA).

The SLAs specifies the expected levels of services to be provided by the Bidder to the stakeholders of the Project. This expected level is also called the baseline service level.

Payment of the Charges payable to the Bidder is linked to the compliance with the SLA metrics laid down in the table provided as Section 3.5.7 to this Schedule of the MSA. A set of parameters has been identified to ensure the desired performance level of HRMS System.

- a. The table lists out the baseline performance level, method of measurement and how low / high performances will be treated.
- b. The Bidder will get 100% of payment if the baseline performance metrics are complied. The Bidder will get lesser payment in case of a lower performance on any parameter as detailed below.

3.5.5. SLA Metrics

The Service Level metrics that define the Service Levels, the method of measurement of each SLA and penalty for not meeting the desired performance level are specified below.

The Bidder shall comply with the Service Levels specified in the document, During the contract period, it is envisaged that there could be changes to the SLA, in terms of addition, alteration or deletion of certain parameters, based on mutual consent of both the parties i.e. BRDS and Bidder.

3.5.6. SLA Monitoring

- 1) The aforementioned SLA parameters shall be measured on a quarterly basis as per the individual SLA parameter requirements, through appropriate SLA Measurement tools to be designed by the Bidder for the purpose and audited by a 3rd party for accuracy and reliability.
- 2) If the performance of the system/services is degraded significantly at any given point in time during the contract and if the immediate measures are not implemented and issues are not rectified to the complete satisfaction of Department or an agency designated by them, then Department will have the right to take appropriate corrective actions including termination of the contract
- 3) The SLAs defined in this Schedule of the MSA, shall be reviewed on an annual basis as BRDS decides after taking the advice of the Bidder and other agencies. All the changes would be made by BRDS after consultation with the Bidder.

3.5.7. **Applicability of MSA**

Apart from the provisions as set out in this schedule, the terms and conditions stated in the MSA shall apply mutatis mutandis to this SLA. In the event of a conflict in interpretation of any Article in the MSA and the SLA, the provisions of the MSA shall prevail. The Table below summarizes the Indicative Performance Indicators for the services to be offered by the Service Provider. The detailed description of the performance indicators, SLA Terms and their definitions are discussed in the following sections.

Note:

In case any failure identified is not attributable to Bidder the penalty shall not be imposed as enforced by the SLA. Decision of committee comprising of BRDS shall final and bindings to Bidder.

Client Application Availability Standard: Client Application should be available 98.0 % of the time for the entire calendar month.

Penalty: Failure to meet above availability requirement will result in a penalty payment of 5% total charges of the Monthly Payments to be paid in that concerned Location /category. Failure to meet above availability requirement for a second consecutive month will result in a penalty payment of 10% of the Monthly Payments to be paid in that concerned Location /category. Failure to meet the above availability requirement for "n" consecutive month will result in penalty payments of 10+n%

Human Resource and Helpdesk Availability Standard: manpower including District Offices, HQ and Data center must be available for the entire calendar month. Attendances of the manpower should be submitted to BRDS for SLA calculation.

Penalty: Failure to meet above availability requirement will result in a penalty payment of 5% total charges of the Monthly Payments to be paid in that concerned Location /category. Failure to meet above availability requirement for a second consecutive month will result in a penalty payment of 10% of the Monthly Payments to be paid in that concerned Location /category. Failure to meet the above availability requirement for "n" consecutive month will result in penalty payments of 10+n%

A pre-proposal meeting for the above assignment was held in the in Patna dated 6/08/2014 at 3:30 PM. Secretary, Rural Development Department briefed the participants about the project and deliberated on the functional requirement, standards, scope of work, manpower to be supplied etc. for the project.

Bidders should take note of the following points –
